"The only detective of genius this country has produced," the N.Y. Times wrote of William J. Burns, the former director (1921-1924) of the





Bureau of Investigations, who's life story and biography was published in the 1968 novel

Marketing for New and Better Business in 2009

Whether you offer your services to business entities such as insurance carriers, law firms, corporations or to consumers, you will have more meetings with better prospects when you understand and implement the concept of **Stand Alone Value**.

Even if you have a great website, no one is likely to use your services without meeting with you first. **NOTE:** While face-to-face meetings are best, telephonic meetings run a close second, if your prospect is not local.

So why would anyone in need of quality investigative services want to meet with you?

The reason I am asking this question is because your prospect is asking themselves the same question every time you ask for, or suggest, an initial meeting.

I firmly believe that whenever a good investigator meets with a prospect, the prospect benefits. However, investigators sometimes have difficulty articulating how the prospect benefits with no strings attached. As an example, when an investigator states that once they meet with a prospect, the prospect will gain a better understanding of the quality of work you can do for them. The prospect will understand how they will benefit from the quality of your services after they sign an Agreement and/ or write you a check. This example articulates value with strings attached ... NOT Stand Alone Value.

A better way is to articulate the benefits of meeting with you even if you never do business with your prospect. Now re-read the first sentence of paragraph 5 (I firmly believe...). You deliver benefits that have **Stand Alone Value**, and you will benefit from learning to articulate them.

As an example of how to articulate Stand Alone Value, in a letter or phone call you might say, "When we meet, I will explain which new technology will add value to your investigation, and

which new technology to avoid because it will only add cost. You will also learn how every report can be structured to present a better perspective (and more value) in litigation."

Invest a few minutes to write a few sentences about how a prospect benefits from meeting with you. It will be time well spent.

In addition, whether or not we do business together, I hope you found this valuable.

A black P.I. Pioneer, Sheridan A. Bruseaux founded the Keystone National Detective Agency on October 3rd, 1919. "Keystone National Detective Agency is the pioneer and only Colored Licensed & **Bonded** Detective Agency in the World," according to the Simms' Blue Book National Negro and Business Directory, first published in 1923.

As we continue to highlight Ten Private Detectives from P.I. History, we are reminded of Leslie T. White, a Los Angeles D.A. Detective in the late 1920's and early 1930's. He became a self-taught fingerprint expert, electronic bugging expert,



"shadow man," and top camera guy. He wrote "Me, Detective," of which the P.I. Museum has a signed copy on display.

He had a successful life as a husband, father, writer, sailor and "Master Model Builder-Structures" after his life as a private investigator. Private Investigator John Kenneth Ek collected the raw intelligence and took many pictures of the Russian ships he saw loaded with missiles along

docks in Cuba during the "Cuban Missile Crisis." Operated Metropolitan Crime Investigators, a Licensed P.I. in Miami, FL in the 1960's and 1970's. He was the creator of the EK Commando Knife.



San Francisco Call Newspaper (Jan. 5, 1900) read "The journals of San Francisco Police Detective Edward Byram, covering in great detail his daily activities from 1876 to 1908, provide many examples of private detective work performed by on-duty officers, including Pinkerton cases." A personally owned watch of Ed Byram is on display in the museum for you to see and is engraved "DETECTIVE S.F. POLICE EDWARD BYRAM."

Diane Penfield (date unknown) - Was she the 1st female licensed Private Eye in CA? On display for viewing is Ms. Penfield's personal gold-filled badge-legal back then. "CALIFORNIA STATE LICENSED 862 DETECTIVE" are the words that appear on it. She began her work in 1940's LA and finished in SF with a nice office on Post Street. The P.I. Museum has visited her former LA home and will one day visit the S.F. office. It's important to do research and learn details about this woman, her work and her life. We recently learned that "Wyatt Earp-Lawman" had once lived at her LA address!

Will you be enshrined in the P.I. Museum one day? Make your own history as an investigator, so others in your future can share the dream.





Legislative Committee Report

CALIFORNIA STATE SENATE

SB 40 (Correa): On January 6, 2009, Senator Lou Correa introduced SB 40 entitled Personal Information: Social Security Numbers. The PICA Legislative Committee is currently reviewing this bill.

SB 202 (Harman): On February 23, 2009, Senator Tom Harman introduced SB 202 entitled Private Investigators: Continuing Education. The PICA Legislative Committee is currently reviewing this bill.

CALIFORNIA STATE ASSEMBLY

There are no known bills pending currently affecting our industry.

CAPITOL HILL—SENATE

S.139 (Sen. Feinstein): On January 6, 2009, California Senator Dianne Feinstein introduced S.139 entitled Data Breach Notification Act. This bill has been referred to the **Committee on the Judiciary**.

S.141 (Sen. Feinstein): On January 6, 2009, California Senator Dianne Feinstein introduced S.141 entitled Protecting the Privacy of Social Security Numbers Act. This bill has been referred to the **Committee on the Judiciary.**

CAPITOL HILL—HOUSE OF REPRESENTATIVES

H.R.122 (Rep. Frelinghuysen): On January 6, 2009, New Jersey Congressman Rodney Frelinghuysen introduced H.R.122 entitled Protecting the Privacy of Social Security Numbers Act of 2009. This bill has been referred to the **House Judiciary Committee, Subcommittee on Crime, Terrorism and Homeland Security.**

H.R.220 (Rep. Paul): On January 6, 2009, Texas Congressman Ronald Paul introduced H.R. 220 entitled Identity Theft Prevention Act of 2009. This bill has been referred to the **House Oversight and Government Reform Committee**.

NCISS LEGISLATIVE DIRECTOR'S REPORT-BRUCE H. HULME

In a report to the NCISS Board of Directors, ahead of the March 2009 Board Meeting, Mr. Hulme made the following submissions:

In light of the political make-up of the new 111th Congress, a Democratic president, and Democratic control of both the House and Senate, I expect the legislative efforts of NCISS in 2009 and 2010 will have to be directed with even greater effort and with increased legislative costs.

Privacy advocates will aggressively push their agenda in 2009, and there will be continued efforts to close our present sources of information and access to records of personal identifying information. I expect the usual security breach, stalking, pretexting, anti-spoofing, identity theft, and Social Security number ban legislation to be the vehicles for such attempts.

<u>Credit Headers Still Protected</u>: I am pleased to write that all federal bills that would have had deleterious effects on the investigative profession failed in the 110th Congress. None of the federal legislation opposed by NCISS was enacted.

In the 111th Congress, Senator Dianne Feinstein (D-CA) has introducted two bills that we will be watching, S-139, the "Data Breach Notification Act" and S-141, the "Protecting the Privacy of Social Security Numbers Act." In addition, there are another dozen bills being monitored by NCISS.

I CALL UPON EACH OF YOU to take the time to visit the district offices of your Senate and House representatives where you reside and where you have offices. Establish a rapport with them and tell them the good work that you do as a private investigator. Our profession needs to eliminate the typical stereotype of the "gumshoe" or sleeping guard and in stead depict a professional investigator that plays a key role in the administration of justice.


